Battles Farm Solar Facility

- No movement
- Proposed new site is in both Essex and East Herts, and will likely go to UDC when application is made.
- County border is the hedge on the right as you look at the National Grid.
- Additional land is Watts' family land. Two farm owners.
- BPC feel Low Carbon have come around this in the wrong way, instead of asking the community what they think Low Carbon should do, it is believed they should have come to the community with what they believe is the right scheme. As they have access to all the heritage personnel, archaeologists, landscaping etc.
- Possibility that if one area cuts land off it might make that land unuseable.

Park Green Solar Facility

No application, only screening opinions currently.

General Comments & Clarification

- BPC have sent letters stating that it is believed that all three proposals need to be looked at as one not three separate sites, this would push it over the required wattage for it to be looked at on a national level.
- There are numerous applications all over the area currently and approx 5 companies are involved in most of them.
- CPRE booklet has been sent to UDC & East Herts, it is also on the Battles Farm and Berden PC websites.
- MPB states he thinks that this needs to be approached from an evidential point rather than emotion.
- DM states BPC are currently stating what has currently been proposed is not acceptable but no application has been submitted yet. This is the case on Battles Farm and Park Green.

- When the application does come and if they have taken on the PC views then maybe it will be reconsidered.
- The Furneux Pelham village survey was based on the original Berden scheme .
- The PC takes on board MPB views. MPB wants to ensure it's a fair argument either way.
- The PC's are trying to keep the villages informed as and when information presents itself.
- FP/BP have taken a different view. Didn't consult the village.
 Protect the Pelhams was born from within the community, not the PC.
- BPC wants to work with the action groups as they are formed.
